1. In February 2023 I tasked Composed Media the job to do a new banner and make adjustments to another banner which they previously did, the banners were \$65 each, after a month I received one banner, for the other banner, the service has not been completed to date and I have not received the banner.
2. Composed Media failed to effectively communicate and deliver service. There were no adjustments made or the return of the banner, communication was stopped altogether.
3. Composed Media should reimburse me for the banner that was not received, the revenue lost from several missed pop up shops, This should include not only the sales that I missed out on, but also any potential future sales that could have been generated from those customers, for multiple trips to Composed Media's place of business incurring gas expenses and the claim expense. And a prayer for a fixed cost of \$50 for money spent filing this claim and printing documents.
