

So I deduct 1000ci from the balance that he had owed on the lawnmower plenty stuff had been broken from it.I sent mr Johnson the remaining balance of 820 he reply (U no satisfied ????? June 12 2023) Not wanting to pay the rest.

On 1 of December 2023 sent this message to mr Johnson
Goodnite sir. I'm giving you 30 more days to make payment otherwise I'm going to take it to the court.if you don't make any payments by the 31 of December 2023 I'll be serving you a summons to appear in the George town courthouse.Thank you have a goodnite!

Mr. Johnson replied Give me the balance.. and also remember all my equipment dem weh u pull up make sure you deduct dem

Mr. Johnson has not and don't want to pay me .he's now saying that I should deduct for part I took off broken tools which al 3 of us as gardeners that were living on the same premises took parts from whosoever tools it maybe. If Mr. Johnson wants pay for those parts I would like to get pay for the scar his son marks on my Toyota voxy.
