- (c) The deceased died intestate.
- (d) The deceased was domiciled at 4201 South Orange Blossom Trail, Orlando, Florida, 32839, United States.
- (e) The deceased was not known by any other name than his true name in connection with the ownership of any property at the time of this death.
- (f) The deceased's spouse is, Sawitree Fendee Van De Steeg.

(g) The net value of the deceased estate is approximately KYD\$300,000.

To the best of my knowledge what is stated above is true.


