AND UPON reading the Fourteenth Affidavit of Michael Penner (signed but unsworn) and Exhibit MP-14 thereto; the First Affidavit of Michael Green sworn 19 April 2024 and the Second Affidavit of Stuart Sybersma (signed but unsworn) and noting that sworn versions would be filed in the second week of May 2024;

AND UPON reading the written submissions of the JOLs dated 1 May 2024;

AND UPON the Judge considering the application to be suitable to be disposed of on the papers without the need for an oral hearing:

- 1 That the JOLs' remuneration for the period 1 October 2022 to 30 September 2023, in the amount of US\$326,738.00, be approved and paid out of the assets of the Company.
- 2 That pursuant to CWR Order 5, rule 4(6):
 - 2.1 Stuart Sybersma of Deloitte & Touche LLP, 8th floor, 60 Nexus Way, Camana Bay, Grand Cayman, Cayman Islands be released from the performance of any further duties as a JOL of the Company; and
 - 2.2 Michael Green of Deloitte & Touche LLP, 8th floor, 60 Nexus Way, Camana Bay, Grand Cayman, Cayman Islands be appointed as Mr Sybersma's successor as JOL of the Company with powers to act jointly and severally with Michael Penner,

without the need for any report and accounts to be prepared, in that respect.
- 3 That the JOLs' costs of the Application be costs in the official liquidation of the Company.
