1. The Defendant is and was at all material times a Cayman Islands carrying on business pursuant to the laws of the Cayman Islands. The Defendant's registered office is 55 Market Street, Camana Bay, PO Box 10708, Grand Cayman KY1-1006, Cayman Islands.
2. On 18 May 2021, the Defendant issued one cheque to the Cayman Islands Government for the payment of services, which was dishonoured by the bank and returned to the Government due to insufficient funds. The details of the dishonoured cheque are:

3. The total sum owed to the Cayman Islands Government is CI\$9,902.00, inclusive of bank administration fees.
4. To date the Defendant has failed or neglected to make full payment on this amount to the Plaintiff, despite repeated demands for payment.
5. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.
