**PARTICULARS OF CLAIM**


1. The Defendant is and was at all material times a Cayman Islands resident. The Defendant has two known addresses; PO Box 33, and 9 Claries Avenue, PO Box 229, Grand Cayman KY1-1301 Cayman Islands.
2. Between 2017 and 2022, the Defendant issued 16 cheques to the Cayman Islands Government for the payment of services, which was dishonoured by the bank and returned to the Government due to insufficient funds. The details of the dishonoured cheque are:
