STATEMENT OF CLAIM

1. The Plaintiff is a body corporate established pursuant to section 5 of the Strata Titles Registration Act (2013 Revision) (the “Act”) and is made up of the proprietors, at any given time, of the strata lots comprising strata plan no 627 (the “Strata Plan”), being the condominium development known as Lantern Point.
2. At all material times, the Defendants were and are the registered proprietors of one of the Strata lots forming part of the Strata Plan, namely Block 23C, Parcel 99REM1H28, known as Unit 28 Lantern Point (the “Property”).
3. The control, management, administration, use and enjoyment of the Strata lots and common property that form part of the Strata Plan, including the Property, is regulated by its the bye-laws registered against the Strata Plan (the “Bye-Laws”).
4. Pursuant to the Bye-Laws:
 - a. clause 61.2, the Defendants are required to pay to the Plaintiff all rates, taxes, charges, outgoings and assessments levied by the Plaintiff in respect to the Property within 5 days of demand;
 - b. clause 61.3.1 and 61.3.2, the Defendants are required to pay the Plaintiff their due proportion of all other costs and expenses incurred by the Plaintiff in connection with the performance of its duties under the Act and the Bye-Laws within 5 days of demand;
 - c. clause 61.3.3, the Defendants are required, in the event of payment not being made within 5 days of the beginning of the month, the Proprietor shall pay late fees thereon of (1) CI\$150.00 per month (non-cumulative) plus interest of 18%.

5. The Plaintiff levies the contributions that the Defendants are required to pay the Plaintiff by issuing monthly invoices to the Defendants that record the amount payable that month and any amounts that the Defendants might be in arrears.
6. Each invoice sent to the Defendants constitutes demand for payment of the amounts due pursuant to that invoice.
7. As at the date of filing this Writ, being 23 August 2024, the Defendants are in arrears to the Plaintiff in the sum of CI\$27,943.02, including interest due under Bye-Law 61.3.3 (the "Debt").
8. The Defendants have breached the Bye-Laws by failing or refusing to pay the Debt.
9. By reason of the Defendants' breach of the Bye-Laws the Plaintiff has suffered loss and damage and seeks to enforce its rights against the Defendants in accordance with the said By-Laws.

Particulars of Loss

Strata Fees

The Plaintiff has suffered in the amount of the Debt being CI\$27,943.02 as at 23 August 2024.

The Plaintiff is entitled to the payment of the Debt and contributions that it levies together with interest up to the date of trial. Such loss is expected to continue to date of trial. Full and further particulars of which will be provided in advance of trial.

Legal Expenses

By reason of the Defendants' breach of the By-Laws the Plaintiff has incurred legal expenses for which the Defendants are, in accordance with Clause 61.2 required to pay on a full indemnity basis.

As at the date of issue of the Writ the Plaintiff has incurred the following reasonable expenses:

Professional fees and disbursements – Nelsons Attorneys-at-Law -
CI\$1,704.18.

Such loss is expected to continue to date of trial. Full and further particulars of which will be provided in advance of trial.

10. Further, the Plaintiff seeks and is entitled to interest from the date of filing this Writ until the date of judgment and post-judgment interest in accordance with clause 61.3.3 of the Bye-Laws the particulars are set out in the table below and continuing at the daily rate of CI\$13.63 until judgment or sooner payment calculated as follows:

11. Alternatively, the Plaintiff seeks and is entitled to interest pursuant to section 34(1) of the Judicature Act (2021 Revision) from and to such dates, and in such amounts, and at such rates, as this honourable Court thinks just.

AND THE PLAINTIFF CLAIMS:

1. CI\$27,643.11;
2. Interest on the following terms:
 - a. CI\$299.91 to the date of the Writ;
 - b. CI\$13.63 per day from the date of the Writ to the date Judgment is entered;
 - c. Post-Judgment interest from the date of judgment until the date payment of the judgment debt in full.
3. Interest continuing at the daily rate of CI\$13.63, as set out in paragraph 10 above, alternatively at such rate from such date and on such amount as this honourable Court thinks just.
4. Costs on an indemnity basis pursuant to 61.3 of the Bye-Laws.
5. Such further and/or other relief as this honourable Court deems appropriate.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of **CI\$27,943.02** together with costs and interest, further proceedings will be stayed. The money must be paid to the Plaintiff or their Attorney.

1. The accompanying form of ***Acknowledgement of Service*** should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings ***must also serve a defence*** on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A ***Stay of Execution*** against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgement of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, ***issue a Summons*** for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

NOTES FOR GUIDANCE

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Court's Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as *(the name stated on the Writ of Summons)*".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
