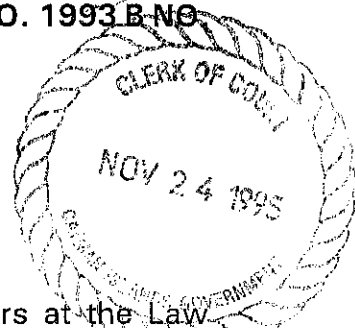

ORIGINATING SUMMONS



LET ALL PARTIES CONCERNED attend before the Judge in chambers at the Law Courts, George Town, Grand Cayman on the 27th day of November, 1995 in the fore/afternoon on the hearing of an application on behalf of Buchanan Partners Limited pursuant to a Letter of Request, dated November 22, 1995 from the High Court of Justice of England and Wales relating to proceedings entitled BUCHANAN PARTNERS LIMITED v. MALAYSIAN SMALLER COMPANIES FUND (CAYMAN) LIMITED (In Liquidation) (Action No. 1993 B No. 1939) the trial of which is scheduled to commence December 4, 1995, for an order that:-

1. The Clerk of this Honourable Court or such other qualified person as may be appropriate be appointed Examiner herein to take evidence of the following person:-
 - (i) Mr. Allan Gee; former Partner of Ernst & Young, c/o The Governor, Her Majesty's Prison, Northward, Grand Cayman, Cayman Islands.
2. That this person be compelled to attend before such Examiner at a time to be fixed and there submit to being examined upon oath or affirmation concerning the testimony required by the High Court of Justice of England and Wales and to produce the relevant documents referred to in the Letter of Request to this Honourable Court dated November 22, 1995.

3. Such Examiner herein do take down or cause to be taken down verbatim in writing the evidence of the said witness and do require the said witness to sign his deposition in the said Examiner's presence and when so completed file the said deposition together with any documents produced as referred to therein with the Grand Court of the Cayman Islands. The evidence should be forwarded to the following:
