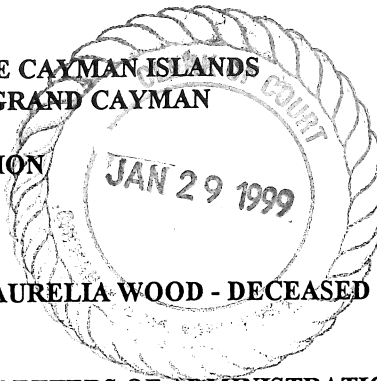

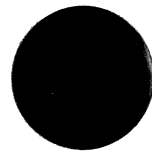
And I declare myself bound unto the Financial Secretary of the Cayman Islands in the sum of CI\$600,000.00.



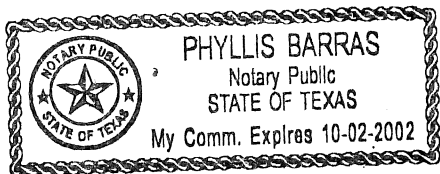
