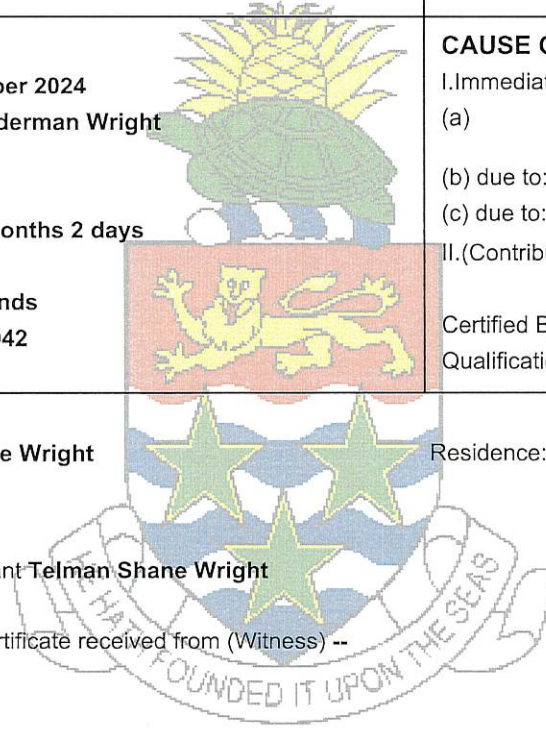

LAST WILL AND TESTAMENT OF BENJAMIN ALDERMAN WRIGHT


THIS IS THE LAST WILL AND TESTAMENT of me, Benjamin Alderman Wright, of 87 Helen Drive, George Town, Grand Cayman, Cayman Islands.


1. I revoke all wills and testamentary dispositions at any time heretofore executed by me.
2. I declare that the validity, construction, application, effects and administration of this my last will and testament is to be governed by the law of the Cayman Islands.
3. I appoint my sons, Telman Shane Wright and Osman Wright, to be the joint Executors and Trustees of this my will. If either of them is unable or unwilling to so act, then I appoint the remaining as the sole Executor and Trustee of this my will. The expression "my Trustees" shall mean the Executors and Trustees or the Executor and Trustee as the case may be, of this my will.
4. I give and bequeath all my real and personal estate whatsoever and wheresoever situate unto my Trustees upon trust to sell call in and convert the same into money with power to postpone such sale calling in and conversion for so long as they shall in their absolute discretion think fit without being liable for loss. My Trustees shall hold the proceeds of sale and my ready money upon the following trusts:


- (1) to pay firstly my just debts, funeral and testamentary expenses;
- (2) then to divide the residue of my estate between the following of my children and The Pines Retirement Home in the percentages indicated respectively:

Telman Shane Wright:	25%
Osman Wright:	25%
Louise Wright:	10%
Stephanie Mae Wright:	10%
Karlene Ann Wright:	10%
Franklyn Benjamin Cruz:	10%
The Pines Retirement Home	10%
Total:	<u>100%</u>

5. If any of my children above pre-decease me, then the share which that child would have taken is to go to their issue if any, and otherwise to be divided in equal shares among the surviving of my children named above.
6. Should The Pines Retirement Home have ceased to exist, have changed its name, amalgamated with another charity, or transferred its assets before my Trustees give effect to my gift, my Trustees shall give effect to such bequest to the body in its new name, amalgamated form, or the body to which its assets have been transferred.
7. In the event Franklyn Benjamin Cruz cannot be located within 12 months of my death, despite best efforts on the part of my Trustees to do so, then I direct that his 10% share of my estate be divided in equal shares between my six children named above.



Powers of Trustee


9. I empower my Trustees:


- a) To sell or join in selling any real or personal property in such manner at such price on such terms and subject to such conditions as my trustee think fit;
- b) To postpone or join in postponing the sale of any property whatsoever (whether a trustee investment or not) for so long as my Trustees thinks fit without being liable for any loss thereby resulting to my estate;
- c) To allow any property or investment that I may have acquired or made in my lifetime to remain in its existing form for such period as my Trustees thinks fit without being liable for any loss thereby resulting to my estate;
- d) To lease or join in leasing any freehold or leasehold property with or without chattels for such period at such rent on such terms and subject to such conditions as my Trustee thinks fit and to accept or effect such surrenders of leases and tenancies as my trustee thinks fit;
- e) To exercise the general powers conferred by the Trusts Law (2011 Revision) of the Cayman Islands (or any legislation for the time being in force amending or passed in substitution for the same) upon trustees including the power to apply income and capital for the maintenance, education, advancement or benefit of any infant beneficiary but with power to advance up to the whole of the presumptive share of capital of any beneficiary; and
- f) At my Trustees' absolute discretion instead of acting personally, to employ and pay any other person or persons including any trustee or beneficially to transact any business or to do any act of whatever nature in relation to the trusts hereof including the receipt and payment of money without being liable for loss incurred thereby and any trustee being a solicitor, accountant or other person engaged in any profession or business may be employed to act and shall be entitled to charge and be paid all professional or other usual charges for any business or act done by him or his firm in connection with the trusts hereof.
