PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. On March 14, 2023 and March 15, 2023, the Plaintiff gave the Defendant \$1000 USD (\$820 CI) to replace the ABS Module on the Plaintiff's 2011 Jeep Wrangler.
2. As of the file of this Plaintiff, the Defendant did not install a working ABS Module, told the Plaintiff to get his own ABS Module and the Defendant would return the \$1000 USD (\$820 CI), and the Defendant has not returned the Plaintiff's money.
3. The Defendant should return the Plaintiff's money, including interest at the prescribed rate as well as the per diem rate until the \$1000 USD (\$820 CI) has been returned, and pay the Plaintiff for his lost time.
4. Details of payments to the Defendant and actions of both parties on Attachment A.

AND the Plaintiff claims:

1. The sum of \$820 ^A +208.50 lost time. (De)
2. Interest in the sum of \$52.43 calculated at the prescribed rate from to date. Interest to continue at the per diem rate of \$0.05 until this matter is settled.
3. Fixed costs of \$150.00 + Bailiff's Fee, alternatively costs to be assessed.
4. Lost time ~~in the sum of \$208.50~~, details on Attachment B.

Attachment A

1. March 14, 2023 – Plaintiff paid to Defendant \$200 USD cash as part deposit for ABS module.
2. March 15, 2023 – Plaintiff paid to Defendant \$800 USD cash as remaining amount due on ABS module.
4. October 9, 2023 – Defendant claims he received the wrong ABS module.
5. February 21, 2024 - Defendant installed the ABS module, but needed codes to reset.
6. Week of July 22, 2024 – Plaintiff ran into Defendant outside of Salty's. He informed Plaintiff that he had a guy scheduled to come to the island at the beginning of August to help him reset the codes.
7. September 9, 2024 – Defendant called Plaintiff to inform him that he couldn't get the guy from the states to come to the island so Plaintiff should find another option and Defendant would give the Plaintiff the money back.
8. October 20, 2024 – Plaintiff asked Defendant for the old ABS module so new mechanic could see if he could reset the codes.
9. October 28, 2024 – After several attempts to get the old ABS module, Plaintiff finally picked up three from Defendant as the Defendant wasn't sure which one belonged to the Plaintiff.
10. November 7, 2024 – Plaintiff's new mechanic looked at the installed ABS module and the other units received from the Defendant. Mechanic thought that the old module was still installed as it was a bad unit.
11. November 8, 2024 – Plaintiff returned the three ABS modules to the Defendant and informed him of what the mechanic had said. Defendant claims that the ABS module was a refurbished unit and had been programmed with the vin of the Plaintiff's Jeep prior to the Defendant receiving it.
12. December 2, 2024 – Plaintiff asked Defendant if he was willing to get the annual inspection done on the Jeep and use a couple of his old panels from another Jeep to replace some bad ones on the Plaintiff's Jeep to help offset the \$1000 owed back to the Plaintiff from the ABS module. Defendant agreed to sand and paint the panels off one of his Jeeps for \$250. Defendant also agreed to get the inspection set up and take the money for that off the \$1000 owed.

13. January 13, 2025 – After several attempts by the Plaintiff to get the inspection paperwork and have the painted panels put on by the Defendant, Plaintiff told Defendant he would get his inspection done somewhere else if the paperwork wasn't ready by January 15, 2025.

14. January 15, 2025 – Registration paperwork was not completed, so Plaintiff took to a different place. Plaintiff dropped off the ABS module that the Defendant installed back to the Defendant and both agreed that the panels would still get put on for \$250.

15. February 22, 2025 – After 13 possible dates set to get the panels installed and the money from the Defendant, and the Defendant unable to follow through on any of the agreed upon dates, the Defendant agreed to pay back the entire \$1000 as the Defendant never delivered on the panels as promised. Plaintiff shared his banking info so Defendant could transfer the money.

16. March 7, 2025 – After 5 failed dates that the Defendant promised to deliver the money, Plaintiff notified Defendant that if the money was not in the Plaintiff's hand or account by 5 pm on March 14, 2025, a claim would be filed to recover the money, as well as interest, lost time, and damages. Defendant acknowledged receipt and understanding of the notification.

17. March 14, 2025 – Plaintiff reached out to see if the Defendant was going to follow through on the payment. Defendant answered that he was in a fishing tournament and would "for sure" get the funds to the Plaintiff on Monday, March 17, 2025 – Defendant would not respond via WhatsApp. Plaintiff called using a different number and Defendant answered and said he was too busy to meet up. He can't just plan to meet at a certain time as he doesn't know what will come up. Plaintiff offered to meet him at his convenience as he has offered in the past. Defendant said it doesn't do any good to meet if he hasn't had time to get the money out of the bank. Defendant said he would get the money that night and call Plaintiff the morning of March 18, 2025.

18. March 18, 2025 – Plaintiff did not hear from the Defendant and texted the Defendant at 12:47 PM asking if payment was going to happen. After no response from the Defendant, the Plaintiff sent a message at 1:56 PM stating that he was starting the legal process tomorrow. Defendant called Plaintiff at 2:05 PM and claimed he had all intentions of paying the Plaintiff. He didn't have all the money, but would pay a portion of the money on Friday, March 21, 2025. Plaintiff agreed that sending money would be a good start and if the

Defendant would just communicate with the Plaintiff he would hold off on the claim as the Plaintiff did not want to have to file the Plaintiff.

19. March 22, 2025 – Plaintiff sent text regarding no payment as promised as well as no communication from the Defendant. Defendant replied that he would have some of the cash on Monday, March 24, 2025 to start the payments.

20. March 26, 2025 – Plaintiff sent message to Defendant regarding no money and no communication again. Defendant responded that he will have the money tomorrow.

21. March 27, 2025 – No communication from the Defendant. Plaintiff called at 4:30 PM to no answer. Defendant sent message at 4:41 PM saying he would call Plaintiff in the morning to give him some money.

22. March 28, 2025 – No communication from the Defendant.

Plaintiff Claim Summary

1. The Defendant received \$1000 US (\$820 CI) from the Plaintiff in exchange for installing a working ABS module on the Plaintiff's 2011 Jeep Wrangler. The Defendant never installed a working ABS module and all parts used were returned to the Defendant. The Defendant should reimburse the money the Plaintiff gave to the Defendant.

2. The Defendant should also pay interest at the prescribed rate on the money given to the Defendant at the date of this Plaintiff as well as at the per diem rate until the claim has been repaid.

3.. The Defendant should also pay for the lost time of the Plaintiff. The Plaintiff spent 4.17 hours going to the Defendant's lot at the Defendant's request and the Defendant did not show or have what was promised, as well as the time the Plaintiff spent sending messages, calling the Defendant, and following up on empty promises by the Defendant. The Plaintiff requests reimbursement of \$208.50, based off of the lost time of 4.17 hours at an hourly rate of \$50.00.

Interest Figured at Prescribed Rate

Monthly Rate
