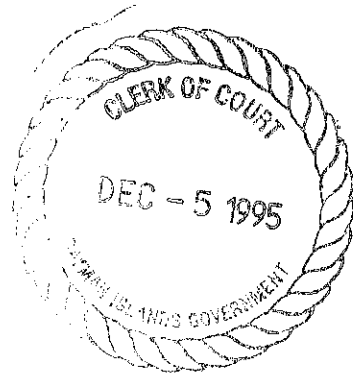
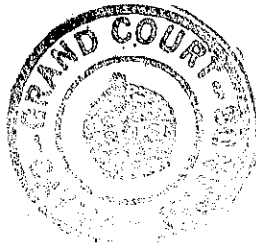

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

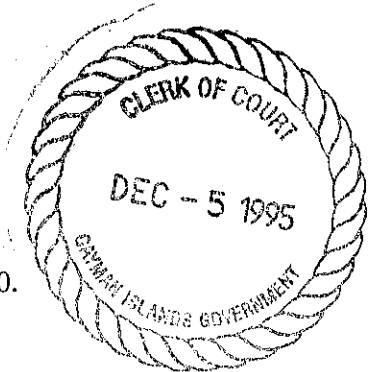
STATEMENT OF CLAIM

1. The Defendant made a Promissory Note for CI\$21,549.03 dated 18th June, 1993 payable to the Plaintiff on demand.
2. On 9th June, 1995 formal demand was made for payment pursuant to the said note.
3. The Plaintiff claims interest pursuant to the Promissory Note at the rate of 15 ½% per annum.

PARTICULARS UNDER PARAGRAPHS 2 and 3

Principal sum CI\$21,549.03

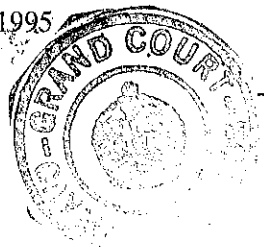
Interest at 15 ½% per annum from 18th June, 1993 to date of Writ CI\$7,997.10.



AND THE PLAINTIFF claims against the Defendant as maker:

1. The said sum of CI\$21,549.03 plus interest pursuant to the Promissory Note equivalent to a sum of CI\$7,997.10 for the period from 18th June, 1993 to the date hereof, together making a total of CI\$29,546.13.
2. Interest pursuant to the Promissory Note on the said sum of CI\$21,549.03 at the rate of 15 1/2% per annum, that is a daily rate of CI\$9.15 from the date of the Writ herein until judgment or sooner payment.
