AND we annex hereto my Affidavit in support of my application and the Certificate of Death of the late **William Evans Rivers, Jnr.**

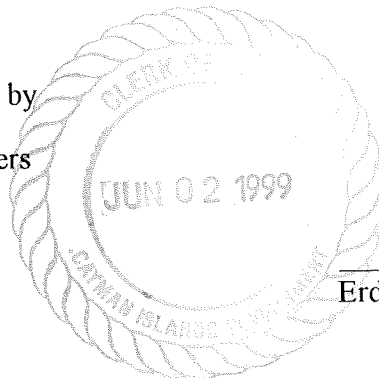

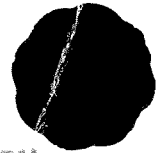
