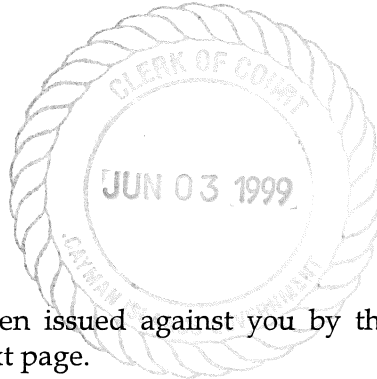

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiffs in respect of the claim set out on the next page.

Within Fourteen days [14] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiffs may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 6 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of re-issue unless renewed by order of the Court.

## STATEMENT OF CLAIM

1. The Plaintiffs are the Joint Official Liquidators ("The Liquidators") of First Cayman Bank Ltd. (In Liquidation) ("The Bank"), whose address is, PO Box 1113 George Town, Grand Cayman, Cayman Islands. The Bank at all material times has lent money to the Defendant.
2. The Defendant's address is PO Box 178, Northside, Grand Cayman and the Defendant was at all material times the recipient of money lent by the Bank.
3. On or about 11th October, 1995, the Bank agreed to lend the Defendant the sum of CI\$3,000.00 which the Defendant agreed to repay by November 1996.
4. The said agreement is contained in or is evidenced by a memorandum signed by the Defendant dated 11th day of October 1995.
5. It was an express term of the said Agreement that the Defendant would pay interest on the amount of the said loan at the staff rate of 7.5% per annum.
6. Pursuant to the said Agreement on the 11th day of October 1995, the Plaintiffs paid to the Defendant by way of a loan the sum of CI\$3,000.00 into a loan account numbered A/c #140-106-058 ("the original loan").
7. On or about the 17th April, 1996, the Defendant sought to refinance the original loan with a new loan in the amount of CI\$3,200.00, under a loan account numbered A/c #140-106-785 ("the second loan"). On the same day the sum of CI\$1,741.28 was paid out of A/c #140-106-058 and into A/c #140-106-785 thus extinguishing the balance of the original loan. The total due by the Defendant as of 17th April, 1996, pursuant to the second loan therefore was CI\$4,941.28.
8. The second loan refinancing arrangement is evidenced by the Bank's account statements for the said periods.

9. The interest payable on the amount of the second loan remained at the staff rate of 7.5% per annum until 30th April, 1997 when, on account of the termination of the Defendant's employment with the Bank, the staff rate was cancelled and a new fixed rate of 15.75% was applied.
10. The Defendant has repaid the Bank the total sum of CI\$3,246.00 on account of the second loan.

11. The Defendant has not paid the balance of the second loan including interest amounting to CI\$3,283.09 and the same remains due and owing by her to the Plaintiffs.

AND THE PLAINTIFF CLAIMS:

1. The said sum of CI\$3,283.09 being the outstanding balance including interest of monies loaned to the Defendant by the Plaintiff on the 17th day of April, 1996, which remains due and owing;
2. The Plaintiff claims further interest on the said sum as aforesaid from the date hereof until judgment or sooner payment at the daily rate of CI\$1.42;
3. Alternatively the Plaintiff claims pre judgement interest pursuant to Section 34 of the Judicature Law (1995 Revision) at the rate of  $7\frac{3}{8}\%$  from the 17th day of April, 1996 to the 31st day of January, 1998; at the rate of  $7\frac{7}{8}\%$  from the 1st day of February, 1998 to the 31st day of December, 1998; and at the rate of 7% from the 1st day of January, 1999 to the date of this Writ;
4. Further and alternatively the Plaintiff claims interest at the rate of 7% pursuant to Section 34 of the Judicature Law (1995 Revision) from the date hereof until judgement or sooner payment;
5. Costs

If within the time for returning the Acknowledgement of Service the Defendant pays the total amount claimed of CI\$3,283.09 (excluding the costs of any additional interest accruing) further proceedings will be stayed. The money must be paid to the offices of the Plaintiff's attorneys-at-law.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE  
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiffs (or on the Plaintiffs if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant

If the Defendant fails to serve his defence within the appropriate time, the Plaintiffs may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

## Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authroised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
