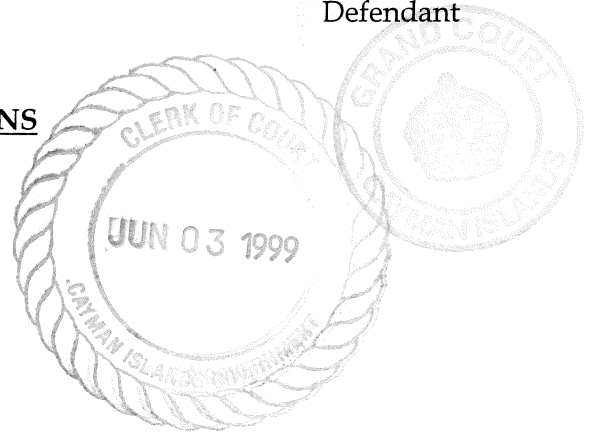

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiffs in respect of the claim set out on the next page.

Within Fourteen days [14] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiffs may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 1st day of June, 1999.

NOTE - This Writ may not be served later than 4 6 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of re-issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Plaintiffs are the Joint Official Liquidators ("The Liquidators") of First Cayman Bank Ltd. (In Liquidation) ("The Bank") whose address is, PO Box 1113 George Town, Grand Cayman, Cayman Islands. The Bank at all material times has lent money to the Defendant.
2. The Defendant's address is, PO Box 2448 George Town, Grand Cayman, Cayman Islands and the Defendant was at all material times the recipient of money lent by the Bank.
3. The Plaintiffs' claim is against the Defendant as a maker of a Promissory Note in the sum of CI\$49,675.00 and US\$600.00 respectively ("The Note") dated the 14th day of November, 1997. The Note was to be interest bearing and to be repaid on demand, which said Note has not been paid. The Plaintiffs refer to the Note for its terms and effect.
4. It was agreed verbally, on 23rd April, 1998 and by letter dated 6th May, 1998, that all payments on the Note were due and payable on the first of each month. The amount being CI\$1,274.00.
5. Payments received under the Note are as follows:

19th October, 1998	-	CI\$851.00
21 October, 1998	-	CI\$423.00
6. The Defendant has repaid the Bank a total sum of CI\$1,274.00 on account of the said loan.
7. Since the 21st day of October, 1998 the Defendant has made no further payments nor has she sought to make any acceptable arrangements to make payments to the Plaintiffs.

As a result the Plaintiffs claim the said sum of CI\$67,720.23 being aggregate balances due under the Note.

AND THE PLAINTIFFS CLAIM:

1. The said sum of CI\$45,000.00, being the outstanding balance of monies loaned to the Defendant by the Plaintiffs on or about the 14th day of April, 1997, together with accrued interest as stated in paragraph 2 below. Further, the said sums of CI\$4,675.00 and US\$600.00, being outstanding balances of monies borrowed by the Defendant from the Bank on or about the 20th day of October, 1997, together with accrued interest as stated in paragraph 3 below;
2. Interest claimed on the sums as stated in paragraph one, subject and pursuant to the terms and conditions of a promissory note executed by the Defendant in favour of the Plaintiffs, on or about the 14th day of April, 1997. Accordingly interest is claimed firstly from the 14th day of April, 1997, to the 20th day of October, 1997 ("the initial term"), upon the sum of CI\$45,000.00 ("the initial sum") at the rate of 3% above the Banks Best Lending Rate (being 3% above US Prime), which is currently 15.75% per annum ("the said rate"). The interest calculated and claimed on the initial sum for the initial term at the said rate is therefore CI\$3,799.74. The initial outstanding sum claimed is therefore CI\$48,799.74 ("the initial outstanding sum");
3. Interest is claimed secondly from the 20th day of October, 1997, to date, upon the initial outstanding sum, together with the said sums of CI\$4,675.00 and US\$600.00 (converted to CI\$504.00) at the said rate. The second outstanding sum claimed is therefore CI\$53,978.74 ("the second outstanding sum"). The interest calculated and claimed on the second outstanding sum for the said term is therefore CI\$13,741.49. As at the 31st day of May, 1999, the total outstanding sum due and owing to the Plaintiffs is CI\$67,720.23;

4. The Plaintiffs claim further interest on the said sum as aforesaid from the date hereof until judgement or sooner payment at the daily rate of CI\$29.22;
5. Alternatively the Plaintiffs claim pre-judgement interest pursuant to Section 34 of the Judicature Law (1995 Revision) at the rate of $7\frac{3}{8}\%$ from the 10th day December, 1997 to 31st day of January 1998; at the rate of $7\frac{7}{8}\%$ from 1st day of February, 1998 to 31st day of December, 1998; and at the rate of 7% from 1st day of January, 1999 to the date of this Writ;
6. Further and alternatively the Plaintiffs claim interest at the rate of 7% pursuant to Section 34 of the Judicature Law (1995 Revision) from the date hereof until judgement or sooner payment;
7. Costs

If within the time for returning the Acknowledgement of Service the Defendant pays the total amount claimed of CI\$67,720.23 (excluding the costs of any additional interest accruing) further proceedings will be stayed. The money must be paid to the offices of the Plaintiffs' attorneys-at-law.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiffs (or on the Plaintiffs if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant

If the Defendant fails to serve his defence within the appropriate time, the Plaintiffs may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authroised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
