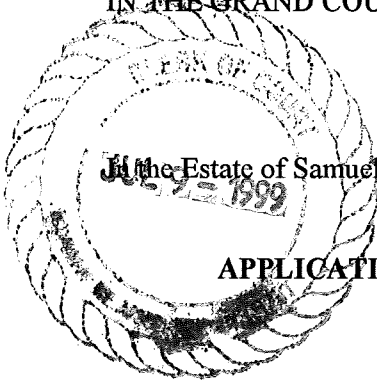

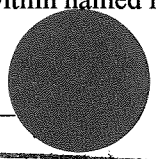
I, Mary R. Scott, declare myself (and my successors) to be bound unto the Financial Secretary of the Islands in the sum of CI\$165,000.00

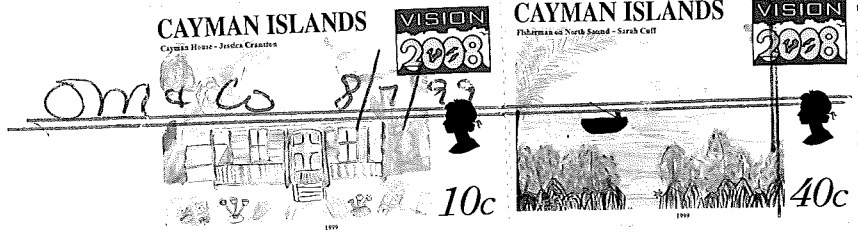

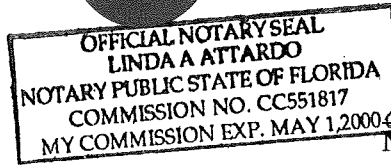
