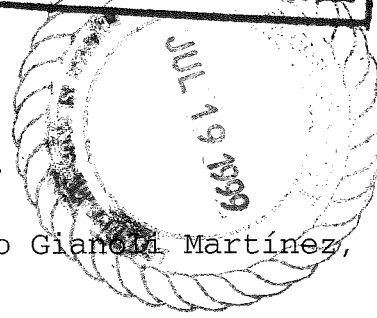

- (b) Within one year of such Resealed Grant to us we will administer the said estate in the Cayman Islands according to the tenor of the Will and directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said estate.

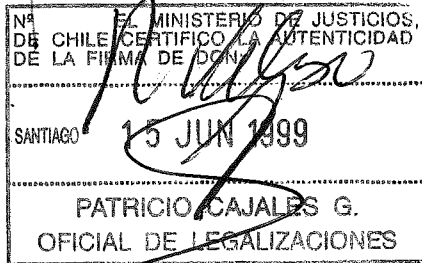
