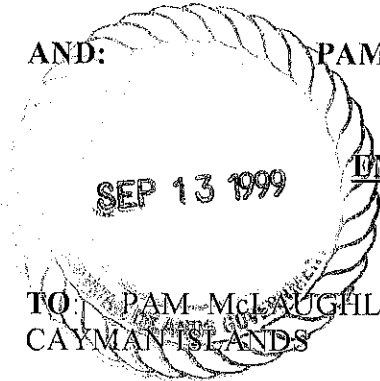

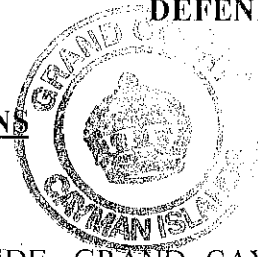

ENDORSED WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 13th day of Sept. 1999.

NOTE – This Writ may not be served later than 4 calendar months (*or, if leave is required to effect service out of the jurisdiction, 6 months*) beginning with the date of issue unless renewed by the order of the court.

STATEMENT OF CLAIM

1. The Plaintiff claims that the Defendant on or about the 3rd June 1999, obtained fill material from the Plaintiff on a credit account.
2. The Defendants said credit account with the Plaintiff is now more that 90 days in arrears, in the amount of CI\$15,531.13.
3. Despite several requests, the Defendant refused and still refuses to pay the sum of CI\$15,531.13 and the sum of CI\$15,531.13 remains due and payable.

AND THE PLAINTIFF claims:

1. The sum of CI\$15,531.13.
2. Interest thereon at the prescribed rate from 27th July 1999 to date.
3. Costs.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered principle office.
