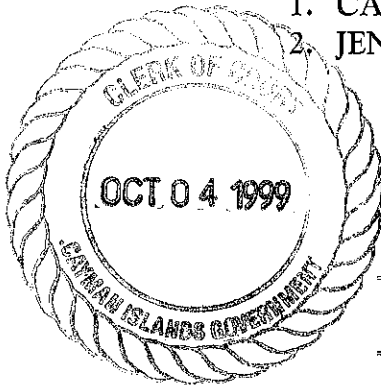

ORIGINATING SUMMONS



TO: Carlos and Jennifer Julian, Garden Courts No. 2, Prospect, Grand Cayman,
the Chargors under the legal charge hereinafter mentioned

LET THE DEFENDANTS, within 14 days after service of this Summons on him,
counting the day of service, return the accompanying Acknowledgement of Service to the
Courts office, P.O. Box 495GT, George Town, Grand Cayman.

BY THIS SUMMONS, which is issued on the application of the Plaintiff, CIBC Bank and
Trust Company (Cayman) Ltd., of CIBC Financial Centre, Edward Street, George Town,
Grand Cayman, as the Chargee under the legal charge hereinafter mentioned, the
Plaintiff seeks the following relief pursuant to section 77 of the Registered Land Law
(1995 Revision), namely:

1. A declaration that the Defendants are in default in payment of the principal sum payable under a legal charge dated 22 December 1994 and made between the Defendants and the Plaintiff ("the Charge"), by virtue of which the property in the Prospect Registration Section Block 22D Parcel 190H2 ("the Property") was charged by the Defendants by way of legal charge in favour of the Plaintiff to secure repayment to the Plaintiff of the principal sum of CI\$71,677.00 with interest at the rate specified in the schedule thereto and payable in accordance with the schedule thereto.
2. Delivery by the Defendants to the Plaintiff of possession of the Property.
3. An order that the Charge may be enforced by the sale by private treaty of the Property.
4. Such further or other relief as the Court thinks fit.
5. Costs.

If the Defendants do not acknowledge service, such judgment may be given or order made against or in relation to them as the Court may think just and expedient.
