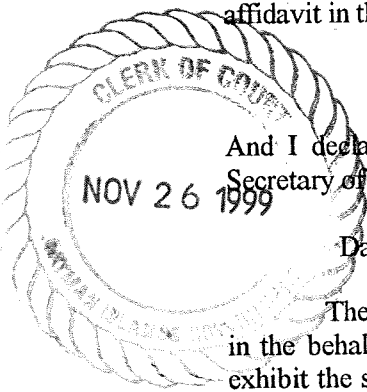
BOND OF SURETIES
