

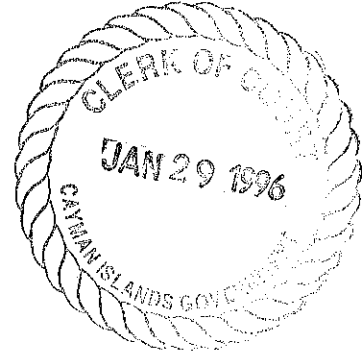

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within *14 days* after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this *29* day of *January* 1996.

NOTE - This Writ may not be served later than 4 calendar months (*or, if leave is required to effect service out of the jurisdiction, 6 months*) beginning with the date of issue unless renewed by order of the Court.

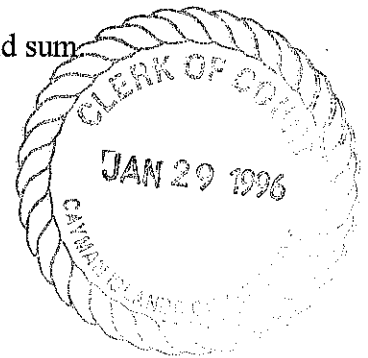
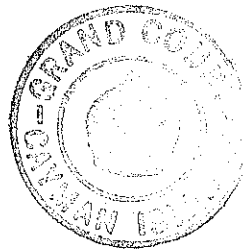

## STATEMENT OF CLAIM

1. Between March 1989 and October 1995 the Plaintiff loaned the Defendant and Mrs. Frances Terry various sums of money. Partial security for these loans was provided by way of a charge over the property at West Bay North West Block 4E Parcel 561 ("the property").
2. On the 17th October 1995 the property was sold by the Plaintiff and the net proceeds of sale were credited to the Defendant's loan account.
3. The net proceeds of sale were insufficient to repay in full the loans made by the Plaintiff to the Defendant and Mrs. Frances Terry and the sum of US\$27,922.32 remains due and owing by the Defendant to the Plaintiff.
4. Despite demand the Defendant has failed to make payment of the aforesaid sum.

### AND THE PLAINTIFF CLAIMS:

1. The said sum of US\$27,922.32.
2. Interest pursuant to Section 34 (1) of The Judicature Law at the rate of 8 3/8% per annum at a daily rate of US\$6.41 per day.
3. Costs.



If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of US\$27,922.32 and CI\$761.96 in respect of costs and fees further proceedings will be stayed. The money must be paid to the Plaintiff or its Attorney.

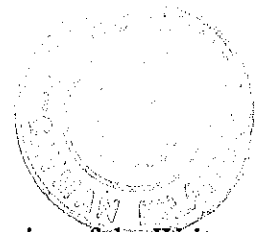

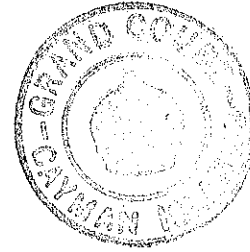
**Notes on address for service**

In the case of a limited company, "residence" means its registered or principal office.
