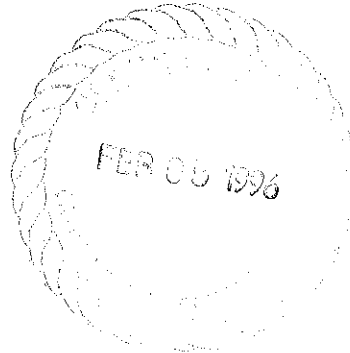

**Within** fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

**NOTE** - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.


**SPECIAL ENDORSEMENT**


1. The plaintiff is a local Company.
2. The defendant works at Island Electrical & Engineering Services Ltd.
3. On the 2nd August, 1995 the defendant obtained a car from the plaintiff for the sum of US\$6,250.00 of which he paid US\$2,500.00 leaving a balance of US\$3,250.00 which he agreed to pay by instalment of US\$500.00 each month.
4. In breach of that agreement the defendant has paid only \$500.00 on the 2nd of Spetember, 1995 and the balance of US\$3,250.00 is still due and owing.
