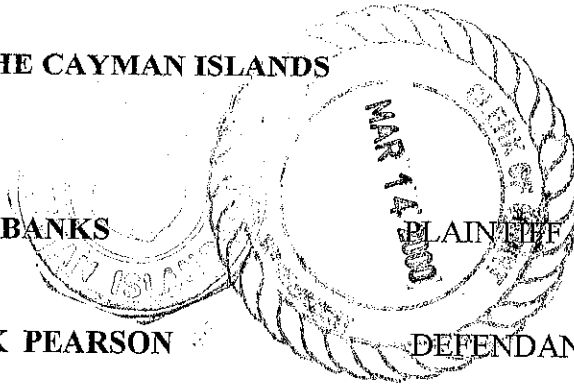

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.


SPECIAL INDORSEMENT

3. The defendant was employed as accountant in the plaintiff's business
4. In November, 1998 it was discovered that customers had paid monies which were not accounted for. When questioned, the defendant admitted that he had taken \$3,660.00 and promised to pay it back.
5. By letter dated the 28th October, 1999 the plaintiff demanded payment in full and on the 7th December, 1999 the defendant gave written undertaking to pay \$100.00 per month commencing on the 30th December, until further arrangements be made. However, he has paid no money.
