

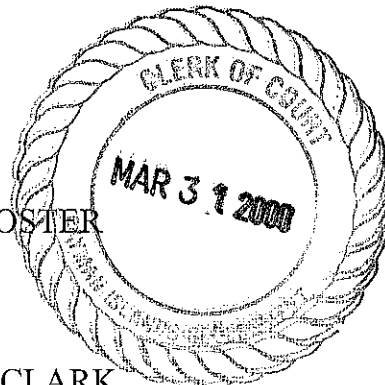

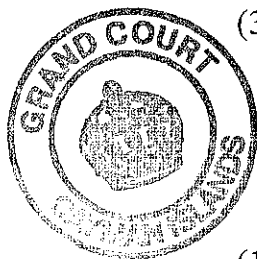

ORIGINATING SUMMONS

And to: (4) Dervyn Scott of P O Box 90, West End, Cayman Brac, Cayman Islands.


Let the Defendants within 28 days after service of this Summons on them, counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office, P O Box 495G, George Town, Grand Cayman, Cayman Islands.

By this Summons, which is issued on the application of the Plaintiffs, Marwick Hensley Foster of N144 W14315 Pioneer Road, Jackson, Wisconsin, USA, Walter Watts of 229 SE 45th Terrace, Ocala, Florida, USA and Alberta Scott of P O Box 102, West End, Cayman Brac, Cayman Islands, the Plaintiffs claim against the Defendants:

1. An order that the First to Third Defendants be removed as administrators of the estate of the said John Hyman Scott (the "Estate") and that the Plaintiffs, or some other fit and proper persons, be appointed as administrators in their place;
2. An order requiring the First to Third Defendants to pay into Court all proceeds of sale received or held by them on behalf of the Estate;
3. Alternatively, an order requiring an account to be given by the First to Third Defendants of all sums received by them on behalf of the Estate;
4. An order restraining the First to Third Defendants until such time as they have been replaced as administrators of the Estate from taking any steps in relation to the Estate, including in relation to the properties set out in the schedule hereto;
5. An order restraining the Fourth Defendant from dealing with the properties set out in the schedule hereto;
6. An order directing the Fourth Defendant to convey to the replacement administrators title to the properties set out numbered 1 and 3 in the schedule hereto;
7. Alternatively, an order imposing inhibitions over the titles to the properties set out in the schedule hereto;
6. An order that the properties set out in the schedule hereto be transferred into the names of the replacement administrators;
7. That all necessary and proper directions be given; and/or
8. Further or other relief; and
9. That provision be made for the costs of this Originating Summons.

If the Defendants do not acknowledge service, such judgment may be given or order made against or in relation to them as the Court may think just or expedient.
