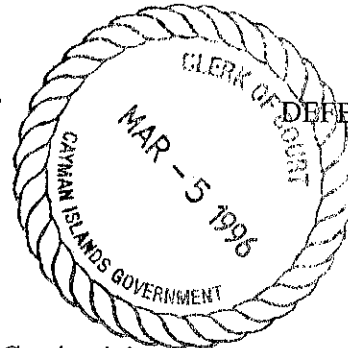
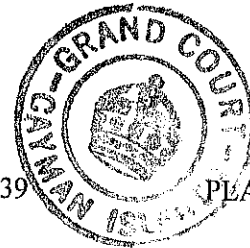

WRIT OF SUMMONS



TO: Nazih Youseff and Heather Ann Youseff of Beach Bay Condominium, Block B, Apartment No. B2 [described in the Land Register as Lower Valley, Block 32D, Parcel 12H18], Grand Cayman, Cayman Islands, British West Indies.

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiffs in respect of the claim set out on the next page.

WITHIN 14 DAYS after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

IF YOU FAIL to satisfy the claim or to return the Acknowledgment of Service within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

ISSUED this 5th day of March 1995.

NOTE: THIS WRIT may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Plaintiffs are the proprietors of Strata Plan No. 39 ("the Beach Bay Condominiums Strata Corporation").

2. The Defendants are jointly and severally indebted to the Plaintiffs in the amount of US\$34,480.71, being contributions together with contractual interest thereon due and owing to the Plaintiffs as at 18th January 1996 from the Defendants pursuant to the by-laws of the Beach Bay Condominiums Strata Corporation in respect of the following properties:-

- (1) Apartment No. B1 [described in the Land Register as Lower Valley, Block 32D, Parcel 12H17] - US\$19,123.50;
- (2) Apartment No. B2 [described in the Land Register as Lower Valley, Block 32D, Parcel 12H18] - US\$10,244.07;
- (3) Apartment No. B3 [described in the Land Register as Lower Valley, Block 32D, Parcel 12H19] - US\$5,113.14.

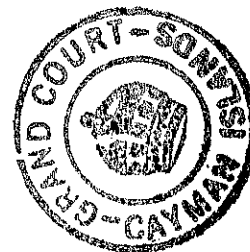
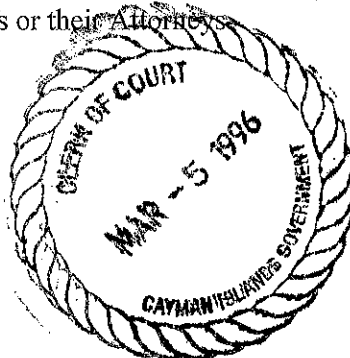
AND THE PLAINTIFFS CLAIM:-

Against the Defendants jointly and severally:-

1. The sum of US\$34,480.71;
2. Interest on the sum of US\$34,480.71 from 19th January 1996 pursuant to contract; alternatively, interest on the said sum pursuant to section 34 of the Judicature Law (1995 Revision) at the rate of 8.375 per cent per annum (being US\$7.91 per diem) from 19th January 1996 to the date of issue hereof, being the sum of US\$363.94, and, thereafter, at the said per diem rate until judgment or sooner payment.

If, within the time limited for returning the Acknowledgment of Service, the Defendants pay the total amount claimed of US\$35,693.10 (inclusive of interest and fixed costs) further proceedings will be stayed. The money must be paid to the Plaintiffs or their Attorneys.
