In the case of a limited company, "residence" means its registered or principal office.

2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.

STATEMENT OF CLAIM

1. The Plaintiff is a paving company incorporated and licensed to carry on business in the Cayman Islands, having its registered offices and place of business at North Sound Road, George Town, Grand Cayman.
2. The Defendant is a resident in the Cayman Islands and was at all material times the owner of Russell Top Job, a company which was incorporated in the Cayman Islands which has now been struck from the company register.
3. By an agreement made on or about 21st October, 1993 it was agreed that in consideration of the Plaintiff extending credit facility to the Defendant, the Defendant would pay the Plaintiff the cost of the services rendered within 30 days of the date of purchase. It was also agreed that if the amount outstanding was not paid prior to the next billing date, interest would be charged thereon at the rate of 1 1/2%.

4. In pursuance of the said agreement, the Plaintiff supplied and delivered to the Defendant the goods itemized in the invoices on the dates and at the costs marked thereon. Copies of the said invoices, have been delivered to the Defendant.
5. That on 20th November, 1993 the Plaintiff further supplied and delivered to the Defendant goods which were also itemized in an invoice and delivered to the Defendant.
6. By letter dated the 14th June, 2000, the Plaintiff, through its Attorneys-at-Laws demanded that the Defendant pay the sum then owed, including interest thereon.
7. As at the 15th September, 2000 the amount due and outstanding by the Defendant to the Plaintiff was CI\$6,667.44 which is comprised of the following:

	Interest	\$294.57

8. Notwithstanding the said demand, the Defendant has made no payment on this account towards the settlement of this debt.

AND THE PLAINTIFF CLAIMS:-

1. The sum of CI\$6,379.20.
2. Pre-Judgment Interest thereon at the rate of 1 ½% per month calculated on a daily basis from 14th June, 2000 to the date of issue of the Writ being CI\$294.57.
3. Post-Judgment Interest thereafter pursuant to the rate of 1 ½% per month.
4. Costs.

STATEMENT REGARDING INTEREST:

- i. The rate of Pre-Judgment Interest claimed is 1 ½% per month calculated on a daily basis.
- ii. The date from which interest is calculated is the 14th June, 2000.
- iii. The interest accruing each day hereafter is CI\$3.33.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$6,670.77 (excluding fixed costs of CI\$500.00 and filing fees of CI\$150.00) further proceedings will be stayed. The money must be paid to the Plaintiff.
