

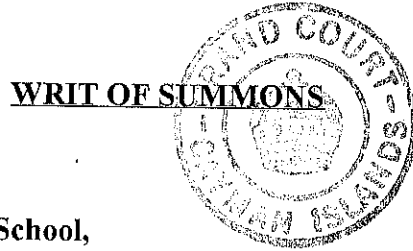


IN THE GRAND COURT OF THE CAYMAN ISLANDS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of a claim set out the next page.

Within fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

Issued the 2nd day of November, 2000.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

Directions for Acknowledgement of Service are given with the accompanying form.

STATEMENT OF CLAIM

1. The plaintiff is a plumber by trade.
2. The defendant is a teacher at the Cayman Islands High School on Walkers Road and is employed by the Cayman Islands Government.
3. On the 16th October, 1998 the plaintiff lent the defendant \$8,000.00 to be repaid within three months. However, the defendant failed to repay the loan and numerous demands have been unsuccessful and the principal sum of \$8,000.00 is still due and owing
6. In addition to the principal sum set out above, the plaintiff is entitled to interest from the dates of the date of the loan the rate of interest being that established pursuant to the Judicature Law (1995 Revision). Interest of \$1,208.89 on the principal sum is also due as of the date of the issuance of this proceedings. The particulars of interest are set out in the schedule attached to the Statement of Claim.

AND the plaintiff claims:

1. Principal sum due \$8,000.00
2. Pre-judgement and post- judgement interest upon the said principal pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules as prescribed from time to time; and
3. Costs as taxed or agreed.

INDORSEMENT

The amount claimed in respect of the debt is \$8,000.00 as principal and US\$1,209.89 as interest until the issue of the writ of summons for a total amount of \$9,209.89. The amount of the fixed costs is \$500.00 and the costs of issuing the writ of summons is \$150.00. If, within the time for returning the acknowledgement of service, the defendant **pays the plaintiff's attorneys-at-law** the total amount claimed in principal and interest, the fixed costs and the costs of issuing of the writ of summons, further proceedings will be stayed. The money must be paid to the plaintiff's attorneys-at-law at the NevLaw Building, 180 Shedden Road.

STATEMENT REGARDING INTEREST

- i. The prescribed rate of interest on \$8,000.00 from 16th October, 1998 to 2nd January, 1999 was 7 7/8 % per annum
- ii. The prescribed rate of interest on \$8,000.00 from 2nd January, 1999 to 1st April, 2000 was 7 % per annum
- iii. The prescribed rate of interest from 1st April, 2000 to 2nd November, 2000 is 8 % per annum
- iv. The date from which interest accrues is from the 16th October, 1998.
- v. The total interest claimed as at the date of issuance of this Writ of Summons is \$1,209.89
- vi. The amount of interest accruing each day following the issue of this Writ is \$1.75

Schedule of Interest Calculated

1. Interest from 16/10/98 to 1/1/99 = $\$8000.00 \times .07875 \times 78/365$ = \$134.62
2. Interest from 2/1/99 to 31/3/00 = $\$8000.00 \times .07 \times 454/365$ = \$696.54
3. Interest from 1/4/00 to 2/11/00 = $\$8000.00 \times .08 \times 216/365$ = \$378.73

Notes on address for service

Attorney: Where the defendant is represented by an Attorney, state the Attorney's place of business in the Cayman Islands. A defendant may not act by a foreign Attorney.

Defendant in person: Where the defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.
