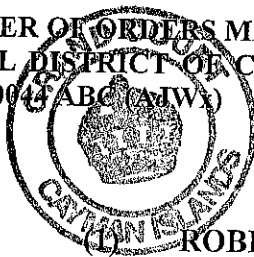

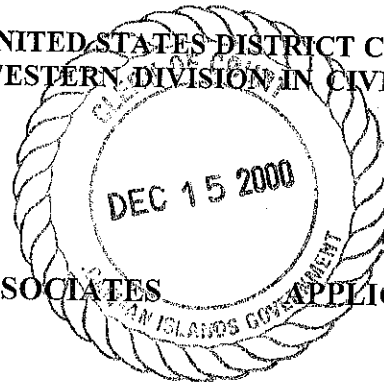

EX-PARTE ORIGINATING SUMMONS

LET ALL PARTIES CONCERNED attend before a Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 25 day of JAN 2001, 2000 at 9:30 o'clock, on the hearing of an application by the Applicants for orders and declarations as follows:

1. **THAT** ROBB EVANS AND ROBB EVANS & ASSOCIATES of 11450 Sheldon Street, Sun Valley, California, 91352-1121, U.S.A., the Applicants herein are the duly appointed Receiver of :

- (1) Kenneth H. Taves
- (2) Teresa Callei Taves
- (3) J.K. Publications, Inc.
- (4) MJD Service Corp.
- (5) Herbal Care, Inc.

pursuant to the Final Order of the United States District Court for the Central District of California, Western Division ("the California Court"), dated 10th August, 2000 which Order supersedes the previous orders of the California Court dated 6th January, 1999 and 15th March, 1999, and extends to the assets owned by Kenneth H. Taves and Teresa Callei Taves, ("the Taves") individually and jointly, their successors, assigns, officers, agents, servants, employees and those persons in active concert with them who receive actual notice of the Final Order by personal service or otherwise, and to the assets of J.K. Publications Inc., MJD Services Corp. and Herbal Care Inc. ("the Corporations"), their affiliates and subsidiaries.

2. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES are hereby authorized to act on behalf of the Taves and the Corporations within the jurisdiction of this honourable Court.
3. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES are authorized and permitted to take all steps necessary or advisable to locate and liquidate all assets subject to the Final Order and set out at paragraph 1 herein belonging legally or beneficially to the Taves and the Corporations or either of them within the jurisdiction of this Court, and to make inquiries and requests for information and documents in whatever form, relating to the assets of the Taves and the Corporations or either of

them which may be in the possession or control of the Respondents or any other person, bank or company within the jurisdiction of this Court.

4. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES be authorized to take possession of and receive, distribute and/or deal with such assets in accordance with the directions and/or orders of the California Court.
5. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES be authorized to issue proceedings in their own name and in the name of the Taves and/or the Corporations of which ROBB EVANS and ROBB EVANS & ASSOCIATES is recognized as Receiver, or defend and/or intervene in proceedings in this honourable Court as duly appointed Receiver of the Taves and the Corporations as shall be necessary for the purposes of performing their duties thereunder.
6. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES be at liberty to apply to this Court for further directions from time to time as Receiver in relation to any matters arising from the Orders of this Court upon proper notice to such person or persons as may be ordered by this Court.
7. **THAT** the said ROBB EVANS and ROBB EVANS & ASSOCIATES is the relevant principal of the Taves and the Corporations named in paragraph 1 of this Order for the purpose of the Confidential Relationships (Preservation) Law (Law 16 of 1976) (1995 Revision) and that ROBB EVANS and ROBB EVANS & ASSOCIATES may be treated as such by the Respondents herein and by any person, bank or company within the jurisdiction to whom an inquiry is directed by their in relation to the Taves and the Corporations or either of them.

8. THAT there shall be liberty to apply generally.
