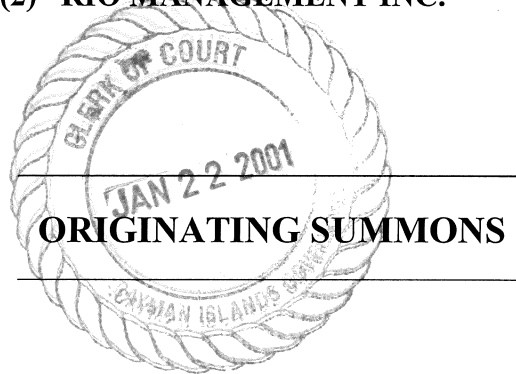
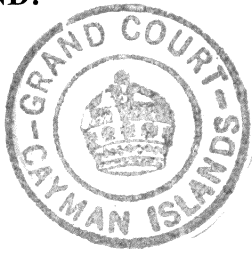


IN THE GRAND COURT OF THE CAYMAN ISLANDS

**ORIGINATING SUMMONS**

**LET ALL PARTIES CONCERNED** attend before a Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 19 day of Feb, 2001 at 9:30 a.m./p.m. on the hearing of an application by the Applicant ("IWG Holdings Limited") for the following orders:

1. A Declaration that IWG Holdings Limited is the true owner of 209,980 shares ("the Shares") of the First Respondent ("Inverworld Ltd") and has been the owner of the Shares since 31<sup>st</sup> December 1996.
2. A Declaration that any steps taken by the Second Respondent in its purported capacity as the owner of the Shares including the following
  - a). The issuing of a notice to shareholders convening a meeting of the shareholders of Inverworld Ltd dated 26<sup>th</sup> October 2000.
  - b). A convening of a meeting of the shareholders of Inverworld Ltd dated 3<sup>rd</sup> November 2000.
  - c). Passing any resolutions at the said meeting of 3<sup>rd</sup> November 2000.

- d). The convening of a meeting of the shareholders of Inverworld Ltd on 10<sup>th</sup> November 2000.
- e). Passing any resolution at the said meeting of 10<sup>th</sup> November 2000.
- f). The filing of a petition in the Grand Court of the Cayman Islands for the purported liquidation of Inverworld Ltd to be conducted under the supervision of the Grand Court of the Cayman Islands.
- g). Any further steps taken in the proceedings relating to the petition referred to in sub paragraph (f) above

be null and void and of no effect.

- 3. Rectification of the register of Inverworld Ltd to provide that IWG Holdings Limited be registered as the holder of 209,980 shares of Inverworld Ltd with effect from 31<sup>st</sup> December 1996.
- 4. Such further or other relief as this Honourable Court may think fit.
- 5. That provision be made for the costs of this application.

**AND LET THE FIRST RESPONDENT** *within 14 days* of service upon him of this summons, including the day of service, return the accompanying Acknowledgment of Service to the Courts office.

**AND LET THE SECOND RESPONDENT** *within 28 days* of service upon him of this summons, including the day of service, return the accompanying Acknowledgment of Service to the Courts office.
