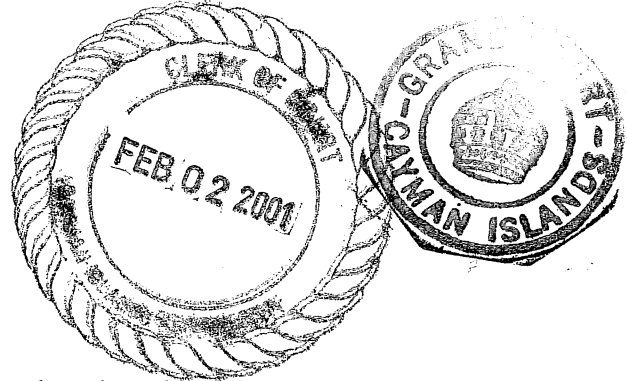

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff, Advantage Capital Group Inc., 7150 East Camelback Suite 300, Scottsdale, Arizona 85251, U.S.A. in respect of the claim set out on the next page.

Within fourteen [14] days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

INDORSEMENT

The Plaintiff, as the assignee of a judgment debt entered against, *inter alia*, Louis G. Reese III ("the Judgment Debtor") on 26th October 1993 in the United States District Court, Northern District of Texas, Case No. CA3-88-2160-R, claims against the Defendants an order that they do make and serve upon the Plaintiff's attorneys an affidavit deposing to such of the following information as is within their possession or power, namely:

- (1) Whether the Defendants have, at any time since 1 January 1992, been instructed as attorneys for, or had dealings with, the Judgment Debtor (being a person whom it is proposed to identify by photographic evidence);
- (2) If so, the name (if other than Louis G. Reese III or any variant thereof) by which the Judgment Debtor is known to the Defendants;
- (3) Details of all Qualifying Assets (as defined below) including:
 - (i) the date upon which the relevant Asset was opened or acquired;
 - (ii) the identity of the relevant bank or other financial institution (if any) at or which the same is or was held;
 - (iii) the name or names in which the same is or was held from time to time;
 - (iv) in so far as the same is no longer in any of the said names, the date upon which the same ceased to be so held and what became of it or its proceeds.

"Qualifying Assets" are bank accounts, investments or other assets which are, or have at any time since 1 January 1992 been, held:

- (i) in one or more of the following names:
 - (a) Louis G. Reese III;


- (b) any other name by which the Judgment Debtor is known to the Defendants;
 - (c) the names specified in the Schedule hereto;
- or
- (ii) upon trust for any of the persons having any of the names referred to in (i) above;
- or
- (iii) by a company, partnership or other entity in respect of which any of the persons having any of the names referred to in (i) above:
 - (a) has or had a beneficial interest whether as shareholder or otherwise;
 - (b) exercise or has exercised powers of management or control whether as director, consultant or otherwise.
