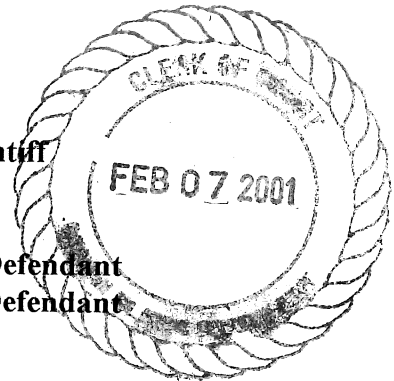

WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of a claim set out the next page.

Within fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

Issued the 6th day of February, 2001.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The plaintiff is a church school.
2. The defendants are the parents of a child, Dennellia
3. On the 31st October, 1994 the defendants signed an agreement with the plaintiff to have their child, Dennellia, educated in the said plaintiff and agreed to pay the fees upon presentation of the bill. In breach of that agreement, the fees went into arrears for 1997 and 1998 in the sum of \$3,071.38 and despite several demands the fees are still unpaid.
4. In addition to the principal sum due as set out above, the plaintiff is entitled to interest from the due date of payment, the rate of interest being that established pursuant to the Judicature Law (1995 Revision). Interest of \$476.86 on the principal sum is also due as of the date of the issuance of this proceeding. The particulars of interest are set out in the schedule attached to the Statement of Claim.

And the plaintiff claims:

1. \$3,071.38 principal as pleaded above
2. Pre-judgement and post-judgement interest upon the said principal pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules as prescribed from time to time; and
3. Costs as taxed or agreed.

INDORSEMENT

The amount claimed in respect of the debt is \$3,071.38 as principal and \$476.86 as interest until the issue of the writ of summons for a total amount of \$3,548.24. The amount of the fixed costs is \$450.00 and the

costs of issuing the writ of summons is \$150.00. If, within the time for returning the acknowledgement of service, the defendant **pays the plaintiff's attorneys-at-law** the total amount claimed in principal and interest, the fixed costs and the costs of issuing of the writ of summons, further proceedings will be stayed. The money must be paid to the plaintiff's attorneys-at-law at the Nevlaw Building, 180 Shedden Road.

STATEMENT REGARDING INTEREST

- i. The prescribed rate of interest on \$3,071.38 from 2nd January, 1999 to 31st March, 2000 was 7 % per annum
- ii. The rate of interest on \$3,071.38 from 1st April, 2000 to 6th February, 2001 is 8% per annum
- iii. The date from which interest accrues is from the 2nd January, 1999 to the 6th February, 2001.
- iv. The total interest claimed as at the date of issuance of this Writ of Summons is \$476.86
- v. The amount of interest accruing each day following the issue of this Writ is \$0.67
