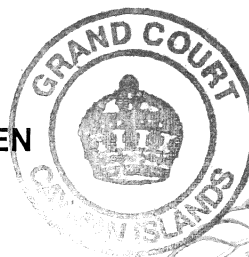

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

In the case of a limited company, "residence" means its registered or principal office.

## Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a *guardian ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.

6. On the 7<sup>th</sup> July 2000 the Defendant made payment to the Plaintiff in the total sum of CI\$300.00 by way of part-payment of the fee notes. These sums have been applied towards the Fee Notes set out above, leaving a balance thereon of CI\$2,394.00.
7. Despite the reminders and demands by the Plaintiff, the balance of CI\$2,394.00 remains due and outstanding to the Plaintiff.
8. The Plaintiff claims interest on the sums due pursuant to Section 34 of the Judicature Law and the Judgment Debts Rates of Interest Rules.

**AND THE PLAINTIFF CLAIMS:**

1. The sum of CI\$2,394.00 against the Defendant.
2. The rate of Pre-Judgment Interest at the rate of 7% per annum from the 1<sup>st</sup> December 1999 to the 31<sup>st</sup> March, 2000; thereafter, at the rate of 8% per annum from the 1st April 2000 to date.
3. Costs.
4. Further and/or other relief.

**STATEMENT REGARDING INTEREST:**

1. The total amount of interest claimed is CI\$140.12.
2. The interest accruing each day hereafter is CI\$.54.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$2,394.00, interest in the amount of CI\$140.12, filing fees and fixed costs of CI\$250.00, further proceedings will be stayed. The money must be paid to the Plaintiff.
