2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.

STATEMENT OF CLAIM

1. The Plaintiff is a land development company incorporated and licensed to carry on business in the Cayman Islands, having its registered offices and place of business at North Sound Road, George Town, Grand Cayman.
2. The Defendant is a resident in the Cayman Islands.
3. By an agreement made on or about 18th May, 1996 it was agreed that in consideration of the Plaintiff extending credit facility to the Defendant, the Defendant would pay the Plaintiff the cost of the services rendered within 30 days of the date of purchase. It was also agreed that if the amount outstanding was not paid prior to the next billing date, interest would be charged thereon at the rate of 1 1/2%.
4. In pursuance of the said agreement, the Plaintiff provided services for the Defendant as evidenced by the invoices on the dates and at the costs marked thereon. Copies of the said invoices have been delivered to the Defendant.
5. By letter dated the 15th February, 2000, the Plaintiff, through its Attorneys-at-Laws demanded that the Defendant pay the sum then owed, including interest thereon.

6. As at the 31st August, 2000 the amount due and outstanding by the Defendant to the Plaintiff was CI\$40,055.10 which is comprised of the following:

Purchases \$22,630.00

Payments \$ 3,846.20

Finance Charge \$22,617.20

7. Notwithstanding the said demand, the Defendant has made three payments on this account towards the settlement of this debt since its inception in 1996.

AND THE PLAINTIFF CLAIMS:-

1. The sum of CI\$41,401.00
2. Post-Judgment Interest thereafter pursuant to the agreed rate of 1 ½% per month.
3. Costs.

STATEMENT REGARDING INTEREST:

- i. The rate of Pre-Judgment Interest claimed is 1 ½% per month calculated on a daily basis.
- ii. The date from which interest is calculated is the 20th November, 1996.
- iii. The interest accruing each day hereafter is CI\$11.31.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$41,401.00 (excluding fixed costs of CI\$500.00 and filing fees of CI\$150.00) further proceedings will be stayed. The money must be paid to the Plaintiff.
