

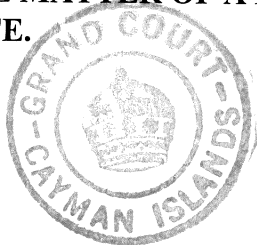

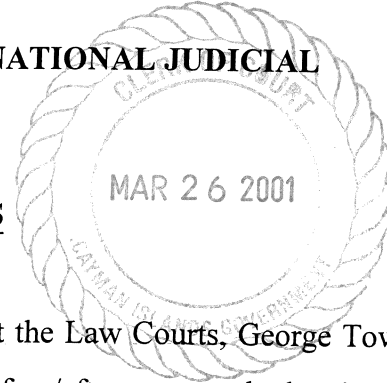




EX PARTE SUMMONS
