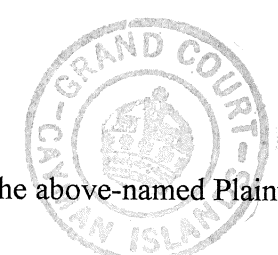
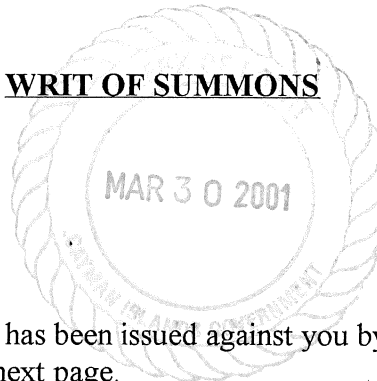

WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of a claim set out the next page.

Within fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

Issued the 30th day of March, 2001.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

Directions for Acknowledgement of Service are given with the accompanying form.

STATEMENT OF CLAIM

1. The plaintiff is an Attorney-at-Law.
2. The defendant works at Morrits Tortuga Club, East End.
3. Between the 11th January, and the 14th February, 2001, the plaintiff did legal work for the defendant at a cost of \$\$5,940.00 of which she paid \$200.00 leaving a balance of \$5,740.00 which she promised to pay by the end of February but she has failed to pay.
4. In addition to the sum due as set out above, the plaintiff is entitled to interest at the agreed rates from the date of the debt until payment. Interest of \$55.35 on the principal sum is due as of the date of the issuance of these proceedings. The particulars of interest are set out in the schedule attached to the Statement of Claim.

AND the plaintiff claims:

1. \$5,740.00 principal as pleaded above
2. Pre-judgment and post- judgment interest upon the said principal pursuant to the agreed rates.
3. Costs as taxed or agreed.

INDORSEMENT

The amount claimed in respect of the debt is \$5,740.00 as principal and \$55.35 as interest until the issue of the writ of summons for a total amount of \$5,795.35. The amount of the fixed costs is \$350.00 and the costs of issuing the writ of summons is \$150.00. If, within the time for returning the acknowledgement of service, the defendant **pays the plaintiff's attorneys-at-law** the total amount claimed in principal and interest, the fixed costs and the costs of issuing of the writ of summons, further proceedings will be stayed. The money must be paid to the plaintiff's attorneys-at-law at the Nevlaw Building, 180 Shedden Road.

STATEMENT REGARDING INTEREST

1. The rate of interest on \$5,740.00 from 14/2/01 is 8% p.a.
2. The total interest claimed as at the date of issuance of this Writ of Summons is \$55.35
5. The amount of interest accruing each day following the issue of this Writ is \$1.26

Notes on address for service

Attorney: Where the defendant is represented by an Attorney, state the Attorney's place of business in the Cayman Islands. A defendant may not act by a foreign Attorney.

Defendant in person: Where the defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.
