


STATEMENT OF CLAIM

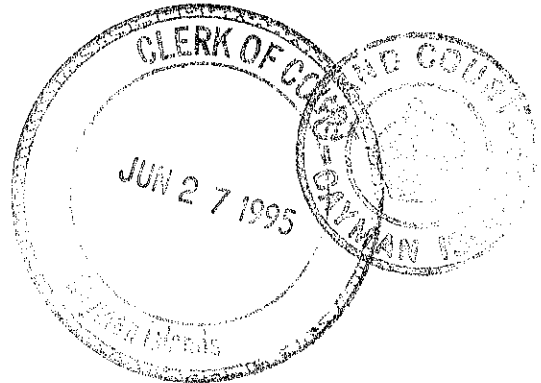
AND THE PLAINTIFF claims:

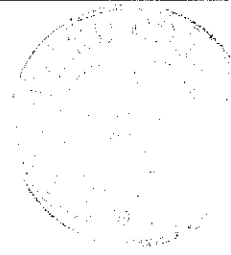

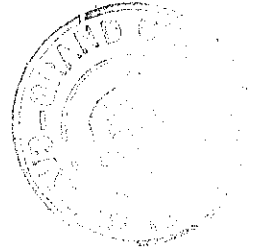
Notes on address for service

In the case of a limited company, "residence" means its registered or principal office.
