

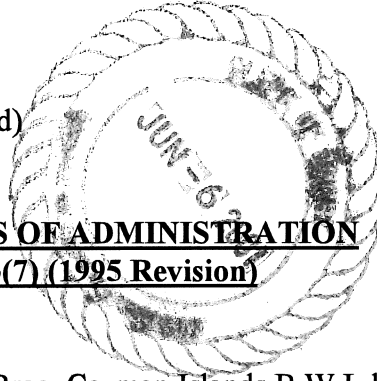

AND I annex hereto my affidavit in support of my application and the certificate of death of the late Frank Rollin Jackson.



BOND OF SURETY


