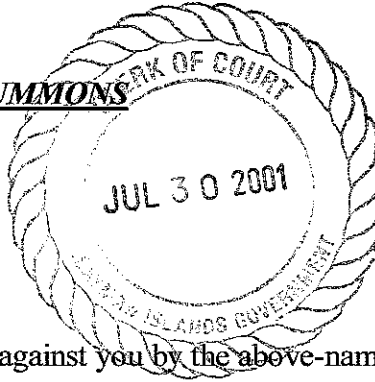

Within 14 days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service, stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

The Plaintiff claims against the Defendant to recover damages in that on or about the 26th day of December 2000 the Defendant so negligently drove and operated his Subaru Justy motor car, bearing license number 33 584, along the South Sound Road, George Town, Grand Cayman, at the junction of the said road and Crewe Road that he caused the same to collide with Honda Accord motor car, bearing license number 73 658 driven by the Plaintiff and thereby caused personal injury, damage and loss to the Plaintiff.

STATEMENT OF CLAIM

1. The Plaintiff is a resident of the Cayman Islands and was at all material times the driver of Honda Accord motor car, bearing license number 73 658.
2. The Defendant was at all material times the owner and driver of Subaru Justy motor car bearing license number 33 584.
3. On or about the 26th day of December 2000 the Plaintiff was driving the said Honda Accord motor car along Crewe Road, George Town, Grand Cayman in a westerly direction when the Defendant so negligently, managed and controlled his said Subaru Justy motor car along the South Sound Road at its junction with Crewe Road aforesaid that she caused or permitted the same to violently collide with the said Honda Accord motor vehicle, driven by the Plaintiff.

Particulars of Negligence

- (a) Driving at an excessive speed in the circumstances;
- (b) Failing to keep any or any proper look-out or to have any or any sufficient regard for other traffic that was or might reasonably be expected to be at the said road junction;
- (c) Emerging onto the said road junction without first ascertaining or ensuring that it was safe so to do and when it was unsafe and dangerous so to do;
- (d) Failing to conform to the stop sign on his side of the road;
- (e) Emerging from a minor roadway unto a major roadway at a time when it was dangerous so to do;
- (f) Failing to give way to the Plaintiff who was driving on the said Crewe Road at a time when she had the right of way at the said intersection;
- (g) Failing to have or to keep any or any proper control of his said motor car.
- (h) Failing to stop, to slow down, to swerve or in any other way so to manage or control his said motor car as to avoid the said collision.

4. By reason of the matters aforesaid the Plaintiff has suffered loss and damage.

5. By reason of the matters aforesaid the Plaintiff sustained severe injuries.


Particulars of Injuries

- (a) Mild head injury
- (b) Fracture of the superio-anterior edge of the body of the third lumbar vertebra
- (c) Deformity at the upper lumbar spine;
- (d) Jarring of right and left facet joints at level L2;
- (e) Permanent stiffness;
- (f) Permanent anterior wedging;
- (g) Severe back pains;

AND THE PLAINTIFF CLAIMS:

- 1. Damages;
- 2. Special Damages;
- 3. Interest thereon at the rate of 8 3/8% per annum;
- 4. Costs.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.

Acknowledgment of service of writ of summons (O.12, r.3)

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, *within that time, issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.
