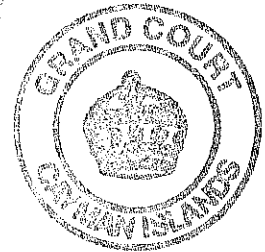
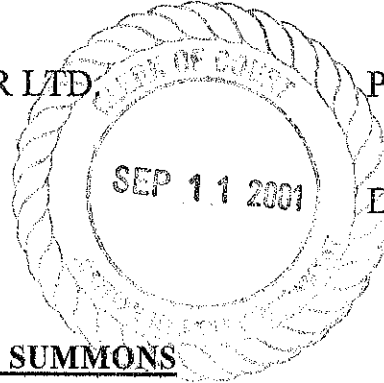

**WRIT OF SUMMONS**

To: ERIK RANKINE

**THIS WRIT OF SUMMONS** has been issued against you by the above named Plaintiff in respect of claim set out in the next page.

**Within** fourteen (14) days of service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P. O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 11<sup>th</sup> September, 2001.

**NOTE:** This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, within 6 months) beginning with the date of issue unless renewed by the order of the Court.

## STATEMENT OF CLAIM

1. The plaintiff is a local rent a car company.
2. The defendant resides at 124 John McLean Drive E.E.
3. On the 31<sup>st</sup> September, 2001, the defendant negligently rode his Kawasaki Motorcycle Registration # 45706 along the Queens Highway so that it collided with the rear of the plaintiff's parked 1999 Honda Civic Motor Car registration # 57415, writing it off.

### Particular of Negligence

- a. Rode too fast
  - b. Failed to control the said motor bike so as to avoid the collision
  - c. Failed to observe the parked motor car
4. And the defendant was charged with (1) Speeding; (2) Driving while disqualified (3) Driving without insurance; (4) Using an unregistered vehicle; and (5) Using License Plates with intent to deceive
  5. By reason of the defendant's said negligence the plaintiff has suffered loss and damage.

### Particulars of Damages

Replacement value of car + costs of appraisal + Police report \$4,757.43

6. In addition to the above sum set out above, the plaintiff is entitled to interest from the date of the 1<sup>st</sup> April, 2001 at the rate of interest being that established pursuant to the Judicature Law (1995 Revision). Interest of \$ on the principal sum is also due as of the date of the issuance of these proceedings. The particulars of interest are set out in the schedule attached to the Statement of Claim.

And the Plaintiff Claims \$4,757.43

2. Pre-judgment and post judgment interest upon the said principal pursuant to the Judicature Law (1995 Revision) and the Judgment debts (rates of interest) rules as prescribed from time to time; and
3. Costs to be taxed or agreed

**INDORSEMENT**

The amount claimed in respect of the debt is \$4,757.43 as principal and \$144.90 interest until the issue of the Writ of Summons for a total of **\$4,902.32**. The amount of fixed costs is \$500.00 and the cost of issuing this Writ of Summons is \$150.00. If within the time for returning the acknowledgement of service the defendants pay the plaintiff's attorneys-at-law the total amount claimed in principal and interest, the fixed costs of issuing of the Writ of Summons, further proceedings will be stayed. The money must be paid to the plaintiff's attorneys-at-law at the NevLaw Building, 180 Shedden Road.

**STATEMENT REGARDING INTEREST**

The prescribed rate of interest on \$4,562.43 from 1<sup>st</sup> April, 2001 to the 31<sup>st</sup> May, 2001 is 8% per annum.

The prescribed rate of interest on \$4757.43 from 1<sup>st</sup> June, 2001 to the 11<sup>th</sup> September, 2001 is 6 ¼ % p.a.

In the case of a limited company, "residence" means its registered or principal office.
