THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 25th day of September 2001.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.


STATEMENT OF CLAIM

1. The Plaintiff is and was at all material times a Category A bank carrying on the business of retail banking in the Cayman Islands.
2. The Defendant is a resident of the Cayman Islands and at all material times was a customer of the Plaintiff.
3. On or about 27 January 1999 the Defendant entered into an agreement with the Plaintiff to borrow CI\$21,600.00 by way of a loan identified by the Plaintiff as SPL #122793. By promissory note dated 27 January 1999 the Defendant agreed to repay the Plaintiff the principal sum of CI\$21,000.00 and interest in the amount of 15% per annum by way of instalments as follows: the sum of CI\$607.72 on 27 February 1999 and the sum of CI\$601.00 thereafter for 47 consecutive months commencing 27 March 1999 until the whole of the principal and interest was paid.
4. The Defendant failed to satisfy the requirement to pay regular monthly instalments as set out above and the loan is significantly in arrears.
5. It was a term of the promissory note that if any instalment was not paid on the date due, the whole balance of the amount loaned then unpaid would become due and payable with interest at the rate of 15% per annum from the date of default until payment.
6. As of the date of the commencement of this proceeding, 25 September 2001, the principal (including late charges) and interest owing by the Defendant is CI\$10,531.57. Interest accrues from 26 September 2001, inclusive, at a daily rate of CI\$2.5337.
7. The Defendant has failed to make satisfactory proposals to the Plaintiff in order to settle his debt to the Plaintiff.

AND THE PLAINTIFF CLAIMS

- i. CI\$10,498.45 being monies outstanding to the Plaintiff further to the above referenced agreement and promissory note as at 25 September 2001.
- ii. Pre and post judgment interest at 15% per annum in accordance with the agreement as pleaded at paragraphs 2 and 5 above.
- iii. Alternatively, pre and post judgment interest at the rate as set from time to time pursuant to the Judicature Law (1995 Revision);
- iv. Costs.

If, within the time for returning the acknowledgement of service, the Defendants pay the total amount claimed (including interest and costs) further proceedings will be stayed. The money must be paid to the Plaintiff or its attorney.

INDORSEMENT

The amount claimed in respect of the debt or demand is CI\$7,700.21 as principal and CI\$2,831.36 as interest until the issue of the writ of summons for a total amount of CI\$10,531.57. The amount of the fixed costs is CI\$500.00 and the costs of issuing the writ of summons is CI\$150.00. If, within the time for returning the acknowledgement of service, the defendant pays the plaintiff or its attorneys-at-law the total amount claimed in principal and interest, the fixed costs and the costs of issuing the writ of summons, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

STATEMENT REGARDING INTEREST

- i. The prescribed rate of interest during the period from 27 January 1999 to the date of issuance of this proceeding and continuing is 15% per annum in accordance with the agreement pleaded herein;
- ii. The total interest claimed as at the date of the issue of the writ of summons is CI\$2831.36;
- iii. The amount of interest accruing each day following the issue of the writ is CI\$2.5337.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of each Defendant or by each Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If A Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
