2. THAT the Defendants and any other person occupying the Property do, within 28 days of this Order, vacate the Property and take all appropriate steps to give the Plaintiff vacant possession of the Property.
3. THAT this Honourable Court do give directions with regard to the price for the sale of the Property.
4. Such further or other relief as this Honourable Court may deem appropriate.

LET THE DEFENDANTS within 14 days of this Summons on each of them, counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office, P.O. Box 495G, George Town, Grand Cayman, Cayman Islands.

3. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
