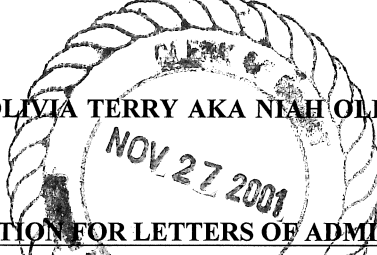

APPLICATION FOR LETTERS OF ADMINISTRATION



AND WE DECLARE ourselves bound unto the Financial Secretary of the Islands in the sum of CI\$608,860.00.


