APPLICATION FOR LETTERS OF ADMINISTRATION

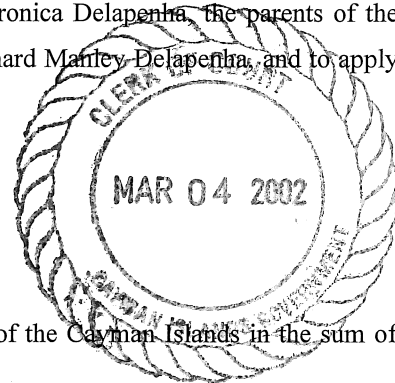




