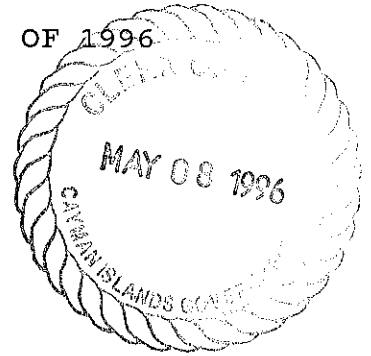

day of May 1996 at 9.30 o'clock in the fore/afternoon  
upon the hearing of an application by John P. Hall II of 1807  
Hunters Glen Drive, Plainsboro, New Jersey, U.S.A., who is required  
by Subpoena dated the 26th January 1996 to testify before the Grand

- the children and remoter issue of the said John P. Hall Snr. namely Melisa Lyne Hall and the Applicant and Toren John Hall (aged 15) and Kristopher J. Hall (aged 9);
- the brothers and sisters of the said John P. Hall Snr. namely:-
  - Gerald Hall;
  - Ronald Hall;
  - Robert Hall; and
  - Shirley Carr;
- the children and remoter issue of the brothers and sisters of the said John P. Hall Snr.
