Within fourteen (14) days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

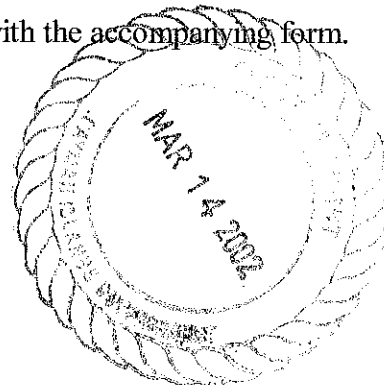
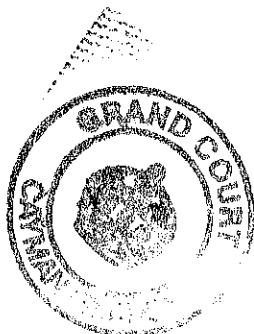
If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than four (4) calendar months (*or, if leave is required to effect service out of the jurisdiction, six (6) months*) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. During September, 2000, the plaintiff agreed to lend to the Defendant the sum of CI\$14,184.19 which the Defendant agreed to repay by monthly instalments of CI\$327.00.

Particulars

The said agreement was made orally between the plaintiff and the defendant November 2000. It was a term of the agreement that the Plaintiff would borrow the money on the defendant's behalf and that the defendant would repay the plaintiff's lender by monthly instalments made by the defendant's employer.

2. Pursuant to the said agreement, the plaintiff paid to the defendant by way of loan the said sum of CI\$14,819.19.

Particulars

The said payment was made by cheque the on or around the 10th day of April 2001, drawn by the plaintiff to the order of the defendant, which was duly met on presentation.

3. The defendant has repaid the plaintiff the total sum of CI\$654.00 on account of the said loan.

4. The defendant has not paid the balance of the said loan amounting to CI\$13,530.19 or any interest thereon and the same remains due and owing by her to the plaintiff.

STATEMENT REGARDING INTEREST

- a) The prescribed rate of interest from 15th April 2001 up to 31st May 2001 was 8% per annum
- b) The Prescribed rate of interest from 1st June 2001 up to 30th November 2001 was 6 ¼ % per annum

- c) The prescribed rate of interest from 1st December 2001 to date is 4 ½ per annum
- d) The date from which interest accrues is from the date of the loan, i.e. 15th April 2001
- e) The total interest claimed as at the date of the issue of this Writ of Summons is CI\$1,234.09
- f) The amount of interest accruing each day is CI\$1.66

SCHEDULE OF INTEREST CALCULATED

- 1. Interest from 15/04/01 to 31/05/01 = \$13,530.19 x .08000 x 47/365 = \$139.37
- 2. Interest from 01/06/01 to 31/11/01 = \$13,530.19 x .06250 x 183/365 = \$423.97
- 3. Interest from 01/12/01 to 14/02/02 = \$13,530.19 x .04500 x 183/365 = \$614.04
- 4. Interest from 01/12/01 to 23/01/01 = \$13,530.19 x .045000 x 34/365 = \$56.71

TOTAL = CI\$1,234.09

AND THE PLAINTIFF claims:

- 1. Payment of the said sum of CI\$13,530.19;
- 2. Interest upon the said damages pursuant to the Judicature Law and the Judgement Debts (Rates of Interest) Rules at the prescribed rate of 7 % or at such other rate as may be prescribed or as this Honourable Court deems just from the date of issuance of these proceedings.
- 3. Costs.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$15,530.19 (including interest and costs) further proceedings will be stayed. The money must be paid to the Plaintiff or her Attorney.]

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgement of Service* should be completed by an Attorney acting on behalf of the Defendant or by The Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is endorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgement is served on the Defendant.

If the defendant fails to serve his defence within 9the appropriate time, the Plaintiff may enter judgement against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgement is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgement of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgement, but he must, within that time, *issue* a *Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words “sued as (the name stated on the Writ of Summons)”.
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description “Partner in the firm of ()” after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description “trading as a ()” after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
