
LET THE DEFENDANT of the address set out above attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman, Cayman Islands, on the day of *Sept* 2002 at *9:30* o'clock the hearing of an application by the Plaintiff of PO Box 689 George Town, Grand Cayman, Cayman Islands, for the following orders: 3

1. A declaration that the Defendant is in default of payment of the principal sum payable under a first Charge registered on 26 January 1995, instrument no. 460/95, varied on 19 April 1995, instrument 2248/95, again varied on 01 August 1997, instrument no. 5778/97, and transferred to the Plaintiff by way of a Transfer of Charge registered 25 November 1999 and varied on 25 November 1999 ("the Charges"), by virtue of which the property in the West Bay North West Registration Section Block 1D Parcel 513 ("the Property") was charged by the Defendant by way of legal charge in favour of the Plaintiff to secure repayment to the Plaintiff of the principal sum, after variations, of CI\$71,250.00 plus interest at the rate specified in the schedules thereto;
2. Delivery by the Defendant to the Plaintiff of possession of the Property;

3. An Order that the Charge may be enforced by the sale by private treaty of the Property (as well as by Public Auction);
4. An Order that the Defendant allow access to the Property for the purpose of viewing and conducting a valuation in furtherance of sale of property;
5. An Order determining the terms and conditions of sale by private treaty, if any;
6. Such further or other relief as the Court thinks fit;
7. Costs.

AND LET THE DEFENDANT within 14 Days after service of this summons on them, counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office.



DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE OF ORIGINATING SUMMONS

The accompanying form of *Acknowledgement of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person. After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Court's Office.
2. If you wish to defend claims made in the originating summons, or intend to attend the proceedings and to participate in them so far as necessary (although not necessarily in an adversarial manner) you should tick the "Yes" box in paragraph 2 of the acknowledgment of service.
3. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
4. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Originating Summons*)".
5. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
6. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
7. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
8. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
9. A Defendant acting in person may obtain help in completing the form at the Courts Office.
