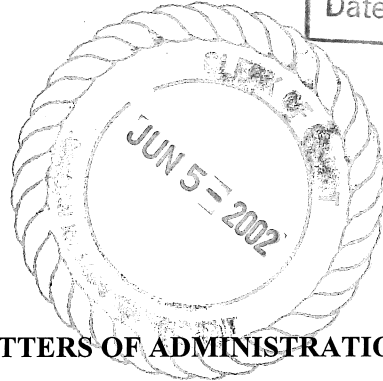

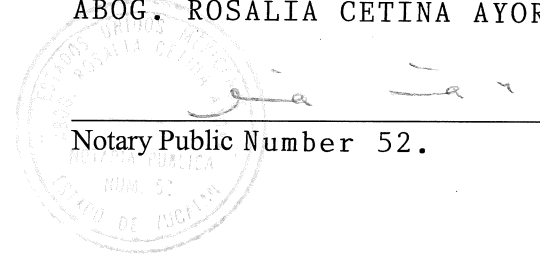


I declare myself (and my successors) to be jointly and severally bond unto the Financial Secretary of the Cayman Islands in the sum of US\$474,000.
