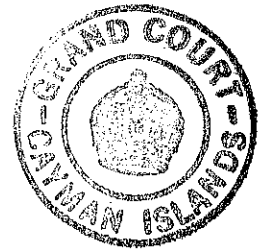


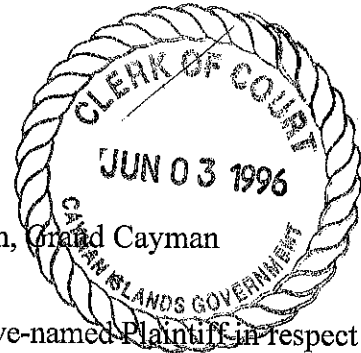

WRIT OF SUMMONS



TO: Winsome Sairsingh, c/o Cayman National Bank, George Town, Grand Cayman

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 3rd day of June 1996.

Note: This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of this Court

STATEMENT OF CLAIM

1. Pursuant to a promissory note dated the 9th June 1993 the Defendant agreed to repay to the Plaintiff the sum of CI\$10,035.00 being an amount loaned by the Plaintiff to the Defendant plus interest on the amount loaned on demand.
2. By letter dated the 12th day of October 1995 the Plaintiff through its attorneys made demand upon the Defendant for repayment of the balance of the amount loaned plus interest then outstanding.
3. The Defendant has failed to make the aforesaid payment and the sum of CI\$5,626.80 remains due and owing from the Defendant to the Plaintiff.

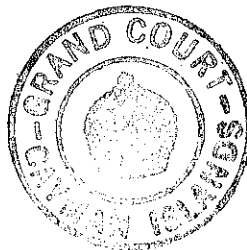
AND THE PLAINTIFF CLAIMS;

1. The said sum of CI\$5,626.80.
2. Interest pursuant to Section 34 (1) of the Judicature Law (1995 Revision) at 7 3/8% per annum at a daily rate of CI\$1.14 per day.
3. Costs.

If within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of CI\$5,626.80 and the sum of CI\$395.00 in respect of costs and fees further proceedings will be stayed. The money must be paid to the Plaintiff or its attorney
