




2. Such further and other relief or consequential orders as this Honorable Court deems just.

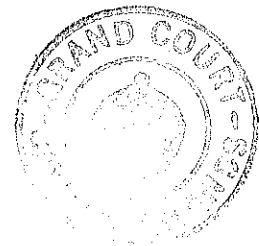
