THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ of Summons on you, counting the day of service, you must either satisfy the claim or return to the Courts Office, P.O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

PARTICULARS OF CLAIM

1. The Plaintiff is a company duly registered under the laws of the Cayman Islands and is licensed to carry on the business of land clearing and removal of heavy equipment and provision of construction services in the Cayman Islands.
2. The Defendant is a resident of the Cayman Islands.
3. By an agreement made on or about 18th July, 1997 it was agreed that in consideration of the Plaintiff extending credit facility to the Defendant, the Defendant would pay the Plaintiff the cost of the services rendered within 30 days of the date of purchase. It was also agreed that if the amount outstanding was not paid prior to the next billing date, interest would be charged thereon at the rate of 1 1/2%.
4. In pursuance of the said agreement, the Plaintiff supplied and delivered to the Defendant the goods itemized in the invoices on the dates and at the costs marked thereon. Copies of the said invoices, have been delivered to the Defendant.
5. By letter dated the 21st March, 2000, the Plaintiff, through its Attorneys-at-Laws demanded that the Defendant pay the sum then owed, including interest thereon.
6. Notwithstanding the said demand, the Defendant has made no payment on this account towards the settlement of this debt.
7. As at the 17th July, 2002 the amount due and outstanding by the Defendant to the Plaintiff was CI\$6,464.90 which is comprised of the following:

AND THE PLAINTIFF CLAIMS:-

1. The sum of CIS\$3,502.50
2. Pre-Judgment Interest thereon at the rate of 1 ½% per month calculated on a daily basis from 18th July, 1997 to the date of issue of the Writ being CIS\$3,152.25.
3. Post-Judgment Interest thereafter pursuant to the rate of 1 ½% per month.
4. Costs.

STATEMENT REGARDING INTEREST:

- i. The rate of Pre-Judgment Interest claimed is 1 ½% per month calculated on a daily basis.
- ii. The date from which interest is calculated is the 18th July, 1997.
- iii. The interest accruing each day hereafter is CIS\$1.75.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CIS\$6,654.75 (excluding fixed costs of CIS\$500.00 and filing fees of CIS\$150.00) further proceedings will be stayed. The money must be paid to the Plaintiff.

Notes on address for service

In the case of a limited company, "residence" means its registered or principal office.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a *guardian ad litem*.
